This notice has been published to inform all concerned, including the applicant consultants, about the Contract Award of Consulting Packages of WaSGISP (*each with a project duration of 5 years*) in accordance with ITC Clause 32 of the RFP. The Project Support Team (PST) NP-DWSSM-290179-CS-QCBS will be responsible for management and supervision works, and the Municipality Support Teams (MSTs) NP-DWSSM-290178-CS-QCBS and NP-DWSSM-290176-CS-QCBS will be responsible for design and supervision works, in respective municipalities of WaSGISP.

In particular, the PST will be responsible for overseeing and providing guidance to the Municipal Support Teams (MSTs) in order to aid and empower Municipalities in tasks such as infrastructure design, construction supervision, and reporting/documentation. Additionally, the PST will offer support to the Project Management Unit (PMU) for comprehensive project management, financial management, governance, institutional, technical, and related support to the Municipalities. This includes the submission of progress reports in alignment with the policies and procedures (technical, institutional, fiduciary, and safeguards) established between the Government of Nepal (GoN) and the Bank. Conversely, the MST's primary role will be to provide technical assistance to the Project Implementation Unit (PIU) for the execution of governance and institutional support, as well as the planning, design, and supervision of infrastructure projects. The MST will have overall responsibility for ensuring the successful implementation and sustained operation of project functions within the Participating Municipalities through the PIUs.

The selection process for all three packages was conducted using the Quality and Cost Selection (QCBS) method. Below, you will find details of the consultants who submitted their proposals for each package.
