- 5. The bids will be opened in the presence of Bidders' representatives who choose to attend on 13:00 Hrs on 2080/10/21 at the office of Department Of Water Supply And Sewerage Management (DWSSM). Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of Nrs.40,000/- which shall be valid for 30 days beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No:1100100102030000 at Rastriya Banijya Bank, thamel Branch and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
